### Title in English of your presentation

Wivi Lönn, a Woman Architect from Finland: Aspects of Early Finnish women in Architecture around the Turn of the 19th and 20th Centuries

#### Abstract in English of your presentation (maximum 1,000 characters)

Nineteenth-century Finland did not have developed traditions of professional training institutes. However, the building industry was growing strongly and there was shortage of skilled professionals. Due to this situation, it is easier to understand the early acceptance of women in systems of formal education. In other Nordic countries, architectural training had been arranged in art academies, and at universities of technology, which admitted women as students quite late.

In Finland, women were granted special dispensation to study at the Imperial Alexander University in Helsinki since the 1870s. The statutes in the Polytechnic Institute also a liberal attitude regarding supernumerary students, making it possible to admit women. Between 1887 and 1894 six women enrolled to study architecture – Wivi (Olivia) Lönn was among them. Wivi Lönn (1872–1966) was the first Finnish woman to have an independent career in architecture. She designed a large number of projects between 1898 and 1945. This paper discusses how this was possible, and concentrates on her early years in Tampere.

#### Your **Curriculum Vitae** (maximum 1,000 characters)

Senior Lecturer in Art History at the department of Philosophy, History, Culture and Art Studies at the University of Helsinki and Adjunct Professor at the Universities of Helsinki and Turku. She has worked as a director of Finnish Doctoral Program for Art History from 2009 to 2013. She has been the head of the research project, "A Portrait of Art History" (2008–2011) at the Academy of Finland, and led the Nordic research network "Visions of the Past" (2008–2012), financed by the NordForsk.

Her published doctoral dissertation, The Fringe of a Profession, Women as Architects in Finland from the 1890s to the 1950s, from 1992 was the first scholarly contribution to deal with women architects in Finland. Her research includes a monograph on modern architecture, for example Aino and Alvar Aalto – A Shared Journey, 2007. Her publications in English include an edited volume on the history of art-historical research in Finland, The Shaping of Art History, 2007, and she is the editor and a contributor of the volume The Challenges of
